NOTE

Under Internal Revenue Regulations, tax-exempt charitable organizations generally must provide requesters with COPIES of:

- Its approved exemption applications, all required attachments and any related correspondence with the IRS, and
- Its three most recent annual information returns (Form 990), including all schedules and attachments (but not the names and addresses of contributors).

In-person requests: A member of the public may request to inspect the documents at any principal office of the organization. The entity must provide the information requested that same day. However, if the request places an “unreasonable burden” on the organization, the staff must provide copies of the requested information no later than the next business day after the unusual circumstances cease to exist (limited to a maximum of five business days after the request).

Written requests: Written requests made by fax, mail, email, or overnight service, which include the requester’s address, must be honored within 30 days of receipt.

Website alternative: Instead of providing copies, an organization may make the documents available on either its own or another organization's website. If it uses this option, it has to: (1) provide an exact replica of the document as was filed with the IRS; (2) advise requesters how to access the forms on the web; (3) the site should charge no access fee and require no special software or hardware to download. Organizations that post this information on the Internet still must honor in-person requests to view the applicable documents.

Permissible charges: Tax-exempt organizations may charge a reasonable copying fee, up to \$1 for the first page and 15 cents for each additional page, plus actual postage costs.

Penalties: An organization that fails to comply with the new disclosure requirements may be subject to the following penalties:

- Annual Information Return – Form 990 - \$20 per day for as long as the failure continues, up to a maximum of \$10,000 for each failure to provide an annual return.
- Exemption Application - \$20 per day with no maximum.
- An organization that willfully fails to comply with these public inspection rules can be subject to an additional \$5,000 penalty.

Private foundation exempt: The new disclosure rules don't yet apply to private foundations. They must still make a copy of their annual return available for public inspection at their principal office for a period of 180 days after publishing a notice of availability.

1 Briefly describe the organization's mission: Hope for Haiti's mission is to improve the quality of life for the Haitian people, particularly children.

4a (Code:) (Expenses \$ 20,057,127. including grants of \$ 18,395,308.) (Revenue \$) Healthcare & Water: Access to primary medical services and clean water is vital for any community to survive and develop. We impacted the lives of an estimated 300,000 individuals through the distribution of about \$18 million dollars' worth of gift in kind medicines & supplies, provided public health training, education and outreach, and by operating our Infirmary St. Etienne, which provided over 16,843 consultations through primary care consultations, dental and laboratory services, and critical referrals for emergency and surgical treatment. We provided about 2,765 consultations through our mobile clinics. We distributed over 7,000 portable filtration systems at the household level and school level providing families the ability to filter clean water for the next ten years.

4b (Code:) (Expenses \$ 498,756. including grants of \$ 120,534.) (Revenue \$) Infrastructure & Economy: We believe that equipping the Haitian people for independent, long term success lies in the ability to foster economic activity, raising the income of households and their trajectory out of abject poverty. FY20, we continued construction on a nine block classroom. Hope for Haiti created 1,500 emergency kits in preparation for any upcoming emergencies. We envisioned and implemented a social business finance program, positioning ourselves to continue effectively accelerating social business entrepreneurs within our circle of program impact. In FY20, we invested \$100,576 in grants and \$16,846.46 loans in Haitian businesses and entrepreneurs.

4c (Code:) (Expenses \$ 336,416. including grants of \$ 26,608.) (Revenue \$) Education: We believe that educating Haiti's youth is the critical component to its long term sustainability and ability to thrive. We provided effective support to 24 partner schools, resourcing 465 primary and secondary teachers through direct salary subsidies, empowering them to educate 6,524 students. We disbursed about \$26,000 to schools for the acquisition of educational materials, books, and related classroom supplies.
